SEMI-ANNUAL UTILITY INCREASE WILL BE ON YOUR JULY BILLING! Utility bills sent out the end of July will include the increase in water and sewer base rates of \$0.25 each.

VANDALISM/SPEEDING We have had several instances of vandalism at both the library and Svilar Park recently. Please, if you see something, report it. Know where your children are and what they are doing. There have also been reports of dirt bikes and loud cars racing around town. Please, let's all be courteous of our neighbors and keep Hudson peaceful.

SANDBAG POLICY- The Town Sandbag Policy is posted at the Post Office and Kai's and on our website. Please look it over. The Town does have some pre-filled bags available for the elderly and disabled residents at Town Hall. Please contact the Maintenance Foreman for information on obtaining them.

DID YOU KNOW...Property owners are responsible to make sure their water meter can be read and is accessible. Please remove weeds, animal waste, etc. Per Ordinance, the OWNER of the property is responsible for any damage to the meter and may be charged an **ADDITIONAL \$40 FEE** if your meter is unreadable or inaccessible. We have resumed reading all meters so please make sure our personnel can access your meter.

NOTICE TO DOG OWNERS: As many are aware, our maintenance foreman was bitten by dogs while reading meters recently. Vicious dogs WILL NOT be tolerated and may be sprayed with deterrent if threatening town personnel. Please keep your dogs contained when you see her out reading meters. Also, please be considerate of your neighbors and clean up your yards and after your dogs. With the warmer weather upon us, the smells are quite unpleasant. Make sure you know where your dog is at all times. Dogs running at large are not allowed and will be reported to the Sheriff's office.

Permits: There are Town Ordinances regarding mobile homes, buildings, fences, etc., so please make sure to read and check on building permits, mobile home/trailer permits, or home improvements, etc.

Auto Pay for your water/sewer bill: Did you know you can now pay your utility bill by text? Auto pay is also available. Your bill will be paid timely, on a specific day of the month. No more writing a check or stopping by Town Hall to pay before the 20th. If you don't want to use auto pay, you can still sign up to use xpressbillpay and pay online at your convenience. **It's free to sign up and free to use!**
